ACO COMMITTEE REPORTS FOR AGM - FEBRUARY 21, 2019

AUCTION - Joan Tooke

The Antiques & Artifacts Committee is a fund-raising committee of ACO Port Hope.

On April 22, 2018, Antiques & Artifacts presented its fourteenth annual Auction and Tag Sale at the Town Park Recreation Centre in Port Hope. This year the planning committee (named below) increased use of social media including Facebook, and Instagram and, with the assistance of a Trinity College student, developed a website. The event was made possible by donations from 78 households. Donated items were assigned to the Auction, Tag sale, Gardens Plus, and other sales areas. Fine jewellery was offered at auction for the first time. During the weekend of the event 80 volunteers worked to set up and to ensure the success of the event which, it has been said, marks the start of the spring season in Port Hope. In addition, an online auction was held in June of 2018.

A total of \$23,000 was transferred to ACO Port Hope as a result of these events. In fourteen years, \$272,000 has been transferred to the ACO by the Antiques & Artifacts Committee.

In November a second online auction was held. This netted over \$4,000 and these funds are budgeted as part of the Antiques & Artifacts 2019 contribution to ACO Port Hope.

The Antiques & Artifacts Committee met 8 times in 2018. Planning is well underway for the Fifteenth Antiques & Artifacts on April 28, 2019 at the Town Park Recreation Centre.

The committee members are Judy Brown, Heather Burnet, Judith Copeland, Felicity Corelli, Olga Cwiek, Mary Dodge Bovaird, Peter Duck, Mary Lou Ellis, Robert McLeod, Ed Pamenter, Will Ryan, Shelagh Stewart, Joan Tooke Mary Trevor and Iris Vermeulen. Lou Pamenter and Charles Wickett are ex officio members; Sharon Hancock joined the committee in September.

ADVOCACY - Bruce Bowden

The year's work really began in the late fall of 2017.

A letter to Heritage Port Hope and the Mayor recommending increased resources for HPH in order to initiate work toward the creation of an Inventory.

A letter to HPH and the Tree Advisory Committee regarding the preservation of trees along Lakeshore Road and the two old oaks in and at the fringe of King's Field.

A presentation to HPH in December urging that the hospital buildings of 65 Ward St. merited Heritage Designation.

In 2018

ACO sent out an e-blast to members outlining our concern that St. John's Anglican Church had concluded that it could not afford to repair the three tall chimneys of its rectory, and, instead, would dismantle them. Members responded by contributing \$7,500 toward their restoration. This work is in progress.

The Committee submitted a formal report to Council, requesting that 65 Ward St. become a Designated Heritage property. A procedural delay had affected the intended report of HPH. Both designation reports were submitted within days of each other, and both were considered by Council, together.

Julie Mavis and Bruce Bowden addressed Council. Two members of HPH, and two members of ACO were asked by Council to meet with Southbridge. At that meeting, diagramed suggestions from the two architects were immediately deemed by the owner, to be unworkable.

Bruce Bowden was interviewed about the designation request on Northumberland 89.7. After two members of Council motion asked Council to reconsider its decision to designate the 65 Ward St. property, Phil Goldsmith and Bruce Bowden were interviewed together on Northumberland 89.7.

The Committee and our ACO executive commissioned research and interventions from Adam Sherwin; these were printed on our website and in social media in support of the property's designation.

When the motion to reconsider was debated by Council, Bruce Bowden and Phil Goldsmith addressed Council during the ensuing debate. Phil brought revised outlines of how the buildings might be re-purposed for long-term care by Southbridge, designed to meet the known reservations of the owner.

Committee members attended the Preliminary Hearing of the Conservation Review Board in November. Bruce Bowden and Phil Goldsmith were granted "Intervenor" status at the hearing, scheduled for Feb. 11, 2019.

The presentations of Bruce Bowden and Philip Goldsmith were submitted to the Board in January, 2019. So too, was the submission of Phillip Carter, the municipality's expert witness.

Julie Mavis, Phil Goldsmith and Bruce Bowden met informally with the incoming Councilors, as had Mr. Moore of Southbridge, earlier. Phil brought an outline of how the entire property might be re-purposed and re-built to provide affordable housing: 20 apartments in the historic hospital buildings; and either 36 apartments or 21 stacked townhouses in separate buildings along Hope St., as well as 8 semi-detached townhouses on Princess St., with parking spaces, and surrounding green set-backs.

Susan Layard completed research about Southbridge's corporate structure and the current state of its license proposals for London and Owen Sound. Tony Jenkins sent an informative letter about this to Council. (Southbridge is cooperating with Sifton, the largest property firm in London, in a redevelopment project in East London; and has walked away from using a downtown heritage site in Owen Sound, as the company had earlier committed to do, preferring, instead, to purchase a "green" site elsewhere in the city.)

A comprehensive illustrated brochure about 65 Ward St., largely working with materials developed by Adam Sherwin, was prepared for all members of Council and Heritage Port Hope.

Anna Gray did much of the planning and coordinating with Pauwels Travel Company in Toronto to provide an exciting itinerary for 30 people at an excellent price. A presentation with photos will take place at the Port Hope Library on Sunday Jan. 27th by the tour guide from Toronto. An e-blast went out to inform all ACO members of this new opportunity. All arrangements can be made with the travel company.
- 2. A venue has been offered and accepted for a spring 2019 musical event at the Joynt's barn on McBride Rd. north of Cobourg, however at this stage we have not found the appropriate performers. If you have suggestions please get in touch with the fund raising committee.
- 3. The Little Station was moved to its new location on Lent Lane with work to rehabilitate and renovate taking place in the spring and summer of 2018. The new space will be the headquarters and gallery for Critical Mass. Fundraising will take place in 2019 to help pay for these costs and sponsors who contribute a significant amount will be honoured on an interpretive sign showing photos of the Little Station in the past and present and telling the interesting history of this delightful building.
