Dear Premier and Ministers,

The Minister of Long Term Care has requested that the Minister of Municipal Affairs and Housing issue a Minister's Zoning order for the historic hospital site, 65 Ward Street. I am a resident of Port Hope who has grave concerns about this build by Southbridge. I'm sure you are aware of the heritage designation of this hospital, and of aspects of its important history.

Last February, following a concerted effort by townspeople, our council rejected the seven storey proposed zoning amendment for reasons including safety, traffic, heritage and the aesthetic cohesion of the streetscape. The impact such a massive tower would have on the surrounding residences is unimaginable.

While I strongly support Long Term Care facilities and services in our town, the 65 Ward Street location is inappropriate for something of this size. Southbridge always maintained the 65 Ward Street lot size was significantly smaller than required, even for their original plan of a three storey facility. There will be little room for anything but parking, already insufficient for their needs.

I urge you to deny the request for the proposed MZO for this property. Southbridge is a welcome partner in this town, and I hope that will explore potential development of larger lands, which have been suggested for a land swap. They are encouraged to consider working with the Municipality to find a site more suitable to their needs.
